WHEREAS JD Striping & Services, Inc. of Ravenna, Ohio submitted a bid for \$50,038.10 in accordance with specifications. The bid submitted was found to meet the bid requirements and has been reviewed and found to be in conformance with the bid requirements.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Olmsted Township, State of Ohio, that JD Striping & Services, Inc., Ohio is the successful bidder as the lowest most responsive and responsible bidder as examined by the Olmsted Township Engineer, Stephen Hovancsek & Associates, Inc.

The stripping project will be funded out of account number 2031-330-360-0000 for \$50,038.10 includes all county roads.
