Nuisance Abatement – Parcel #26504018

**RESOLUTION OF THE BOARD OF TOWNSHIP TRUSTEES OF OLMSTED
TOWNSHIP, CUYAHOGA COUNTY, OHIO**

This date, May 9, 2025, Trustee Aaron, moved the adoption of the following Resolution:

WHEREAS, information has come before the Board of Trustees concerning the condition of the real property located at **27161 Bagley Road, Olmsted Township, OH 44138, PPN: 26504018**, within the unincorporated territory of Olmsted Township; and

WHEREAS, based upon this information, the Board finds that a condition constituting a nuisance exists on the premises identified herein above, caused by the accumulation of **large branches and debris** throughout the property; and

WHEREAS, the Board of Trustees determines that the property owner's failure to maintain the property in a clean and orderly condition constitutes a nuisance in violation of **Ohio Revised Code Section 505.87**.

NOW THEREFORE, it is hereby **RESOLVED** by the Trustees that:

Pursuant to Ohio Revised Code Section 505.87, notice is hereby provided via U.S. certified mail, return receipt requested, to the owner(s) of the land identified above and to any holders of liens of record upon the land. The notice states:


As the owner of the land located at 27161 Bagley Road, Olmsted Township, OH 44138, PPN: 26504018, you are ordered to remove the large piles of branches and debris throughout the property. The presence of grass, garbage, refuse, and debris as defined by Ohio Revised Code Section 505.87 constitutes a public nuisance. If the nuisance is not abated within **seven (7) days** of the date of this notice, the Board of Trustees may cause the removal of such materials. Any expenses incurred by the Board in performing this task will be entered upon the tax duplicate and will become a lien upon the land from the date of entry.

If certified mail service is not perfected, notice is authorized by any means provided for in ORC 505.87, including posting and/or publication.

Trustee ZVER seconded the motion and, thereupon, the votes in favor of the Resolution were recorded and are reflected by the signatures hereto.


