### **Swimming Pool Permit Application Required Information Guide**

- Site drawing indicating size and location of the pool and equipment, on the property.
- Site drawing needs to indicate all property lines and set back measurements to the pool.
- Required Electrical drawings should indicate wiring methods, conductor type and size, conduit type and burial depth. All branch circuits and overcurrent protection. All pool equipment manufacturers specifications and installation manuals, including all pumps, heaters, pool automation panels, lighting, and lighting transformers. Bonding and grounding of pool shell, ladders, equipment and equipotential bonding ring.
- Required Mechanical drawings should indicate the type of gas piping to be installed, burial depth, location, and where gas line is originating from. Heater manufacturer specification and installation instructions.
- Required Fence drawings should indicate type, location, and size and height of the fence, property lines, location of lockable gate, post hole depths, etc.
- Required Concrete drawings should indicate location and size of concrete pad, base material and depth, concrete material and depth.
- HOA letter of approval; if applicable.
  - All contractors shall be currently registered with Olmsted Township
