

RESOLUTION 107-2025

Authorizing the Filing of an Application for 2026 Cuyahoga County Supplemental Grant Program - Mackenzie Road Sidewalk

Cuyahoga County, Ohio

Trustee Auton Moved for adoption of the Following:

Be It Resolved by the Township Trustees of Olmsted Township

WHEREAS, the Olmsted Township Board of Trustees (“Board”) is committed to improving public infrastructure and community facilities within Olmsted Township, Cuyahoga County, Ohio (“Township”), for the benefit of all residents and visitors, without discrimination; and

WHEREAS, the Cuyahoga County Community Development Supplemental Grant (“CDSG”) Program has been established to be administered in conjunction with, and through the same process as, the Cuyahoga County Community Development Block Grant (“CDBG”) Program; and

WHEREAS, the CDSG Program is administered by the Cuyahoga County Executive through the Cuyahoga County Department of Development, and is funded through the Community Development Fund as established in Chapter 709 of the County Code, with not less than one million five hundred thousand dollars (\$1,500,000.00) allocated annually for the program; and

WHEREAS, the CDSG and CDBG Programs support a wide range of community development activities aimed at revitalizing neighborhoods, promoting economic opportunities, and enhancing public facilities and services to improve the overall quality of life for residents; and

WHEREAS, the Board has identified a project known as the Mackenzie Road Sidewalk Project, as more fully described in the attached *Exhibit A*, which meets the national objectives of the CDBG Program by benefiting low- and moderate-income persons through the improvement of their living environment and the prevention or elimination of blight; and

WHEREAS, the Board held a duly advertised public hearing on October 2, 2025, for the purpose of receiving public comments and considering the Township’s application for 2026 CDSG funding; and

WHEREAS, the Board has determined that the Mackenzie Road Sidewalk Project is an eligible activity for funding under the CDSG Program and that no other readily available funding sources exist for the proposed improvements.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Olmsted Township, Cuyahoga County, Ohio, that:

1. The 2026 Cuyahoga County Community Development Supplemental Grant Application for the Mackenzie Road Sidewalk Project is hereby approved and authorized for submission.
2. The Board hereby certifies that, in its informed judgment, the proposed project satisfies the national objectives of the Community Development Block Grant Program, including

the benefit to low- and moderate-income persons and the improvement of public facilities and living environments.

3. The Township Administrator is authorized and directed to execute and submit all necessary documents in connection with the application process.

Trustee Coyle seconded the Motion, and thereupon, the votes in favor of this Resolution were recorded and reflected by the signatures hereto.

BE IT FURTHER RESOLVED: that it is hereby found and determined that all formal actions of this Board of Township Trustees concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and any of its committees that resulted in such formal action, were in a meeting open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
