

RESOLUTION NO. 141-2025

Adopting Building and Zoning Fees and Permit Charges

Cuyahoga County, Ohio

Be It Resolved by the Township Trustees of Olmsted Township
that

WHEREAS, a necessity exists to amend the schedule of fees to be charged by the Building Commissioner for Building and Zoning Permits as authorized in Chapter 519 and 505 of the Ohio State Revised Code.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Olmsted Township, Cuyahoga County, State of Ohio, that the following schedule supersedes all previously established fees and is hereby adopted.

General building permit fees.

Heating, ventilating, gas piping, air conditioning and refrigeration permit fees.

Plumbing and sewer permit fees. (See Cuyahoga County Board of Health)

Electrical permit fees.

Plans examination fees.

Zoning fees.

Permit conditions and special fees.

GENERAL BUILDING PERMIT FEES

The following fee schedule shall prevail for all building and zoning permits required and issued by the Building Commissioner:

Note a: For the purpose of this fee schedule "Residential" means one-, two-, and three family detached dwellings, and their accessory structures. For the purpose of this fee schedule "Commercial" means structures other than 1-2-3 family detached dwellings and their accessory structures.

Note b: For the purpose of fee calculation, any fee based on units of square ft or linear ft shall be rounded up to the next whole unit of measurement.

*Note c: * Indicates plan review fees apply*

NEW CONSTRUCTION/ADDITION FEE FORMULA (CONSTRUCTION FEE FORMULA)

The fee formula is used for all new construction and additions. In effect, all new construction and addition building permit fees shall be computed using this formula and table. Fee includes permit for structure (not including plan review and trade fees), sidewalk, driveway, and certificate of occupancy.

FORMULA PERMIT FEE = gross area x type of construction x permit fee multiplier

Permit fee multiplier = 1% Residential New Construction
 .5% Residential Additions
 1% Commercial New Construction and Additions

PLANS EXAMINATION FEES

For work requiring the examination of plans, the following fee schedule shall prevail. Plan review fees may be required to be paid at the time of building permit application. Additional fees will be paid once review of application is completed. Plan review fees may change depending on time spent on review. Plan review fees can be waived by the Building Commissioner if it is determined that no plan review is required for the scope of work. A reduced base fee of \$25 per review may be charged in lieu of the standard base fee at the discretion of the Building Commissioner for limited review projects such as fences, concrete/asphalt, accessory buildings under 200 sq ft, etc.

Surcharges as required by the State of Ohio will be assessed on all building, HVAC, plumbing and electrical permits as follows:

PROFESSIONAL SERVICES, INSPECTIONS AND OTHER EXPENSES IN BUILDING AND/OR ZONING MATTERS

- (a) When a property owner or an authorized agent for a property owner files a building and or zoning application or an application to the Zoning Commission or Board of Zoning Appeals they shall be responsible to pay for professional services, consultants, special inspections and other expenses that shall be incurred by the Township in consideration of such application when such services are necessary as determined by the Building Commissioner. These fees shall be in addition to any zoning and /or building fees required by other Resolutions.
- (b) Upon failure to pay the fees required by this section the Township may take any and all legal action necessary to recover such funds.
- (c) All professional fees, inspection fees and other expenses incurred by the Township in considering an application shall be paid from the funds deposited or billed to the applicant on a monthly basis.
- (d) All funds not expended when a deposit is required shall be returned to the applicant within a reasonable amount of time following the completion of professional services for which the funds were deposited, or balance may be applied to permit costs. The refund request **must be in writing** and approved for the deposit balance be released.
- (e) "Professional Services" shall mean services rendered by the Engineer, Planning consultant, Architect, Legal Counsel, Plans Examiner, inspectors and/ or other consultants required by the Township Building Commissioner.
- (f) The applicant shall be responsible to pay the hourly rate of such consultant and other fees this consultant may charge plus 20% for administration costs.

TOWNSHIP PROPERTY FEES

All fees for Township projects are waived, unless projects requires the use of contract inspectors or professional services then the permit fee will be equal to the cost of those individuals.

OLMSTED FALLS SCHOOL DISTRICT FEES

All fees Olmsted Falls School District shall be granted a 10% discount off the regular fee cost or a minimum of \$60.00 for permits prior to starting work. Fees will be 100% plus applicable penalties for permits obtained after work started. If project requires the use of contract inspectors or professional services, then the permit fee will equal to the additional cost of those individuals.

That is any section, subsection, sentence, clause or phrase of this resolution is, for any reason, held to be unconstitutional; such decision shall not affect the validity of the remaining portions of this resolution. The Board of Trustees of Olmsted Township hereby declares that it would have passed this resolution and each section, subsection, clause and phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrases be declared unconstitutional.

BE IT FURTHER RESOLVED that it is hereby found and determined that all formal actions of this Board of Township Trustees concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
