YES. The following items are accepted
during your city's Household Hazardous Waste collection.

	• Oil or solvent-based paint, sealers, primers, or coatings (aerosols or liquids) • Any Aerosol cans with flammable/combustible warnings • Varnishes, polyurethanes, shellacs • Paint thinner, mineral spirits, turpentine, Acetone • Pesticides, herbicides, fungicides, fertilizers • Caustic/Corrosive household cleaners • Pool chemicals • Automotive fluids, motor oil • Adhesives, roof tar, driveway sealer • Kerosene, gasoline, lighter fluid • Mercury/Mercury Containing Items (thermometers, thermostats, etc.) • Any other household chemical marked Poisonous, Caustic, Flammable, Corrosive, or Combustible

Consider these other disposal options for some items.

BATTERIES 	• Dispose of single-use (non-rechargeable) alkaline batteries (AA, AAA, C, D, etc.) in the regular trash. • Rechargeable batteries (Lithium Ion, Nickel Cadmium, etc.) can be recycled at hardware, home improvement or electronics retail stores near you. Batteries+Bulbs stores also accept these for a small fee. • Lead acid (vehicle) batteries can be recycled at a scrap metal yard. LATEX PAINT		Latex paint is 99% water and 1% rubber and is safe to dispose with your household trash when it is dried out. Dry out your latex paint by exposing it the air, mixing in a drying agent like cat litter or Oil-Dri, then place it in a regular trash bag and put it out with your weekly rubbish collection. FIRE EXTINGUISHERS		Empty contents into a bag and throw away the bag and any plastic on the extinguisher. Metal extinguishers can be taken to a scrap metal yard. www.cuyahogarecycles.org/recyclables/fire_extinguishers
FLUORESCENT BULBS		Compact fluorescent bulbs (small, twisty CFLs) can be recycled for free at Lowe's. Look for a drop box near the main entrance or customer service desk. Some local Batteries+Bulbs retail stores will accept and recycle all types of bulbs and ballasts, including fluorescent tubes. Stores are in Akron, Macedonia, Mayfield Heights, and Parma. MEDICATIONS		Rx drop boxes are available at police stations throughout Cuyahoga County. Seasonal collection events are conducted by the Northeast Ohio Regional Sewer District, U.S. DEA and local retail stores. Details at www.cuyahogarecycles.org/recyclables/medications
PROPANE TANKS AND CYLINDERS		• Drop off 20# grill tanks at any Blue Rhino location and write "For Recycling" on the tank. • Small tanks for camp stoves, lanterns, etc. do not have easy disposal options. The district does periodic collections for these tanks. Details at www.cuyahogarecycles.org/recyclables/propane_tanks • Helium tanks should be emptied and punctured per the instructions that came with the tank. Recycle at a scrap yard. Details at www.cuyahogarecycles.org/recyclables/helium_and_oxygen_tanks
BUSINESS WASTE		By law, business waste cannot be disposed of through the Household Hazardous Waste Program. Businesses with hazardous waste should contact the Cuyahoga County Solid Waste District for a list of companies that can assist with disposal. Call (216) 443-3749 for a recommendation.
