

RESOLUTION NO. 105-2022

*Retaining Fabrizi Trucking and Paving Company, Inc.
Snow and Ice Treatment Agreement for December 1, 2022 through March 31, 2023*

This Snow Plowing Contract is entered by and between Fabrizi Trucking & Paving Co., Inc. with offices located at 20389 First Avenue, Middleburg Heights, Ohio 44130 and at 6751 Eastland Road, Middleburg Heights, Ohio 44130, ("Contractor") and Olmsted Township ("Customer") this 14th day of September 2022.

Cuyahoga County, Ohio

Be it Resolved by the Township Trustees of Olmsted Township, that

WHEREAS, the Olmsted Township Board of Trustees deems it necessary to retain the professional services of Fabrizi Trucking and Paving Company, Inc. to support the snow and ice removal activities as defined in the proposal dated September 1, 2022. Contractor is in the business of providing snow plowing services, road resurfacing, berming, mailbox replacement, regrading ditches, and is qualified to perform all necessary work and will provide all supervision, labor, and equipment, and;

WHEREAS, Customer has 22 miles of roads which require snow plowing; and;

Customer has a facility for storing Fabrizi's trucks on Fitch Road in Olmsted Township. Township will purchase and store all salt at their facility.

Contractor agrees to be available to plow 24 hours per day, 7 days per week at the request of the Customer.

Contractor further agrees to provide a Certificate of Insurance adding the Customer as additional insured and maintain Workers' Compensation Coverage during the term of the contract.

Contract agrees to use the route map for the snow and ice treatment as supplied by the Customer.

- Single Axle Truck with Plow & Salt Spreader \$ 108.00 per hour
- John Deere 544 Loader or Equivalent Machine \$2800.00 per month

Customer shall authorize any additional work required during heavy storms prior to the commencement of such work at the following rates:

Pricing for berm repair, concrete repairs, ditch cleanup, and landscaping restoration to be provided on a site by site basis.

This contract is for the term of December 1, 2022 through March 31, 2023.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Olmsted Township, Cuyahoga County, State of Ohio, that: Fabrizi Trucking and Paving shall be retained to provide said professional snow and ice removal services at a cost not to exceed \$50,000 beginning December 1, 2022 and extend through March 31, 2023. Said Proposal is marked as Exhibit A and attached hereto and made a part of here of as though fully rewritten herein.

BE IT FURTHER RESOLVED; that it is hereby found and determined that all formal actions of this Board of Township Trustees concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and any of its committees that resulted in such formal action, were in a meeting open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
