RESOLUTION OF THE BOARD OF TOWNSHIP TRUSTEES OF OLMSTED TOWNSHIP, CUYAHOGA COUNTY, OHIO

This date, March 23, 2022, Trustee Zver, moved the adoption of the following Resolution:

WHEREAS, information has come before the Board of Trustees concerning the condition of the real property located at *26929 Cook Rd. Parcel #262-23-003* within the unincorporated territory of Olmsted Township; and

WHEREAS, based upon this information, the Board finds that a condition constituting a nuisance exists on the premises identified herein above, caused by the condition of vegetation, garbage, refuse or other debris at the subject location; and

WHEREAS, the Board of Trustees determines that the owner(s) maintenance of such vegetation, garbage, refuse or other debris, constitutes a nuisance.

NOW THEREFORE, it is hereby RESOLVED by the Trustees that:

Pursuant to Ohio Revised Code Section 505.87, notice shall be provided by U.S. certified mail, return receipt requested, to the owner(s) of the land identified above and to any holders of liens of record upon the land stating that: You, as the owner of the land located at *26929 Cook Rd. Parcel #262-23-003*, are hereby ordered to:

- ORC 505.86 Remove unsafe accessory building(s) (Front Garage and rear garage) the maintenance of which has been determined by the board of trustees to be a nuisance. If such:
- ORC 505.86 Unsafe accessory building's (Front and rear garage) is not removed, or if provision for its abatement or removal is not made within thirty (30) days, the board will provide for the
- ORC 505.86 Removal of unsafe accessory building's (garage)
- ORC 505.87 Abatement, control, or removal of vegetation, garbage, refuse, and other debris. (Please see picture on report)

If certified mail service is not perfected, notice is authorized by any means provided for in O.R.C. '505.87 and 505.86, including posting and/or publication.

Trustee Alton seconded the motion and, thereupon, the votes in favor of the Resolution were recorded and are reflected by the signatures hereto.

Subject: Repair or Demolition of garages at 26929 Cook Road, Olmsted Township, Ohio 44138

As the Fire Chief, I have determined the garage structures located adjacent to the residential dwelling at 26929 Cook Road to be unsafe & structurally defective. These structures appear to be in an advanced stage of dilapidation due to the deteriorating condition of the roof and the other structure being out of plumb. This determination is based on the excessive sagging and decay of the roof and other structural members as visible from the exterior of the structure. This condition may be placing an additional strain on the adjoining structural members thereby creating this unsafe condition. With this unsafe declaration, I further warrant the repair or demolition of these structures occur forthwith and in accordance with the provisions outlined in the Ohio Revised Code, Section 505.86.


