PROFESSIONAL SERVICES AGREEMENT BETWEEN OLMSTED TOWNSHIP, OHIO AND F & B ENGINEERING, INC.

This Professional Services Agreement (hereinafter referred to as "Agreement"), is made as of this 10th day of January 2022, between Olmsted Township, Ohio, (herein after referred to as "Township"), located at 7900 Fitch Road, Olmsted Township, Ohio 44138, and F & B Engineering, LLC, (herein after referred to as "F&B"), located at 9671 Oxford Glen Drive, Mentor, Ohio 44060.

REPRESENTATION:

F&B is a specialized construction industry-consulting firm whose services are limited to the interaction of the Ohio and International Building Codes to governmental agencies, as well as the architectural, engineering, and construction disciplines.

WITNESSETH:

IN CONSIDERATION of the mutual covenants hereinafter contained and mutual benefit to be derived by the parties from the performance hereof, the parties herein agree as follows:

SCOPE OF SERVICES:

Commercial Plan Reviews

- A. F&B will provide commercial plan review services as directed by the Township Building Official in accordance with the Ohio Building Code. A code expert with specialized expertise in building, electrical, mechanical, fire protection disciplines will provide plan reviews.
- B. Plan reviews will be professionally prepared and communicated to the Township Building Official in a formal plan review letter. Work will be performed by Dennis Bowman, Building Official/Master Plans Examiner Certificate No.6240 and Jerry Flanik, Building Official/Plans Examiner Certificate No. 464.

F&B COMPENSATION:

F&B contract with the Township is an hourly rate contract. F&B shall bill the Township the following hourly rates for services:

Commercial Building, Mechanical, Electrical, & Fire Protection Plan Reviews: \$120.00/hour

Special Rates:

F&B shall charge the Township at a rate of \$150.00 per hour for time associated for preparation and/or participation regarding board of appeals hearings, legal depositions, and litigation trials.

PAYMENT TERMS

Invoices will be submitted monthly based on that portion of work completed during the month. Invoices are due upon receipt. Outstanding balances in arrearage more than thirty (30) days shall carry a finance charge 1.5 % per month or 18% per annum.

TERM

F&B shall start work on this contract promptly upon its execution with the Township and shall continue until the defined work scope is either completed or terminated. F&B hourly rate is fixed on this contract for a twelve (12) month period from the date of contract signing.

TERMINATION:

Either party can terminate this contract in writing at any time for any reason, with or without cause. The Township is responsible to pay F&B for all time expended under this contract up until the time of contract termination, no matter how the Township classifies said termination.

INSURANCE

F&B shall maintain \$1,000,000/\$2,000,000 of professional liability insurance and \$1,000,000/\$2,000,000 of commercial general liability insurance at its own expense throughout the term of this Agreement.




