Leadership Salary Increase

Be it Resolved by the Township Trustees of Olmsted Township, that

WHEREAS, the Olmsted Township Police Chief, Police Lieutenant, Fire Chief, Assistant Fire Chief, Director of Public Service, and Building Official have completed performance appraisals both individually and with their direct supervisor, and the merit increase was recommended by their direct supervisor, and;

NOW THEREFORE BE IT RESOLVED by the Board of Trustees of Olmsted Township, State of Ohio, that:

SECTION 1: The recommendation of salary increase is as follows and is hereby accepted as submitted.

Police Chief Matthew Vanyo – 3% Increase

Fire Chief Patrick Kelly – 3% Increase

Director of Public Service Eric Williams – 3% Increase

Building Official David Faciana – 3% Increase

The Police Chief reviewed Lt. Mark Adam recommendation of 3%.

The Fire Chief reviewed Asst. Fire Chief Christopher Methvin recommendation of 3%.

SECTION 2: The above-referenced increase shall commence February 21, 2021.

SECTION 3: The terms described in this resolution constitute the terms of employment and shall not be construed as a contract.

BE IT FURTHER RESOLVED; that all Department Heads participated readily to address the Covid-19 pandemic which altered the workplace greatly. We commend the Leadership Team for following policies to ensure our workforce was protected and that our workforce was CV19 free for 8 months into the pandemic.

BE IT FURTHER RESOLVED; that it is hereby found and determined that all formal actions of this Board of Township Trustees concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and any of its committees that resulted in such formal action, were in a meeting open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
